Vendor acknowledges Heritage Event Company LLC and the hosting venue as the authoritative bodies responsible for management of the event and insuring that all Vendors comply with the above rules and regulations. Vendor acknowledges that all arrangements for Vendor space rental at this Heritage Event Company event must be made exclusively with the Promoter. Promoter reserves the right to refuse service and/or rental options at Promoter’s discretion, for any reason. All approved, participating Vendors must complete and sign registration forms and submit total fees due in order to secure space reservation for the event. **NO SPACES WILL BE HELD WITHOUT PAYMENT & REGISTRATION SUBMITTED.** Vendor acknowledges that Heritage Event Company LLC makes no express or implied guarantees of performance or sales of vendor merchandise at any Heritage Event Company event. Vendor acknowledges that payments made to Heritage Event Company by Vendor are for the sole purpose of renting exhibit space at the event and/or rental of certain equipment provided by Promoter upon request of Vendor (tables, chairs, electrical service, etc.) As with any business venture, there is a risk of incurring loss at any event. Past performance is not necessarily indicative of future results. Vendor is solely responsible for the outcome of Vendor sales at any Heritage Event Company event. Vendor agrees not to pack merchandise prior to close of the show without express, written permission from Promoter. Vendor agrees to not solicit to the public or other Vendors for participation in non-HEC events. Vendor agrees not to distribute literature of any kind at the event. Vendor understands that failure to comply with Terms & Conditions for Participation may result in expulsion from any Heritage Event Company event at any time and barred participation in future events at Promoter’s discretion. In cases of Vendor dismissal, walk-out during the show, or Vendor protest or Vendor complaint submitted during or after the event, **NO REFUNDS WILL BE ISSUED. I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property.
